In addition basic understanding of key points of pesticide labels and SDS's will be covered to ensure all attendees know what is what and more importantly what to do with information contained on each.

The session will also focus on the standards that would prevent these incidents from occurring and how arboricultural operations can be planned and conducted to reduce the risk of serious incidents.

11:00 AM - 12:00 PM Aerial Rescue Training with your Local Fire Department

The Westminster Forestry staff hosted an Aerial Rescue Training through ISA/RMC in 2016 and then took it a step further by inviting the Westminster Fire Dept. to participate. That led to training with part of the WFD Tech Rescue Team and we will be training with the North Metro Tech Rescue Teams in March 2017. One telling statement from the firemen was “we climb down to rescue someone, not up”. Fire Departments are not trained in rescuing tree climbers nor have the necessary equipment. The means of delivering information will be with a Power Point, photos, and a small panel of 2-3 presenters including Westminster Forestry staff and Fire Dept. Tech Rescue Team. Participants will be encouraged to attend Aerial Rescue Training and learn how to get the local fire department involved. They will learn how to cross train with the fire department and what equipment the fire department may need to get. This presentation directly relates to the conference theme of “Safety” by involving fire tech rescue teams with climber aerial rescues.



Bryan McCoy, City of Westminster

Bryan McCoy is the Forestry Specialist for the City of Westminster's Forestry crew. 1:00 PM - 2:00 PM Fundamentals of Gear Inspection

The Fundamentals of Gear Inspection will be a combination power point presentation and “gear in hand” demonstration of inspection techniques. The process of gear inspection will be discussed to review who should carry out the inspections, when they should be done, the various outcomes and how they should be documented. Particular attention will be given to the mind set and qualifications of individuals performing gear inspections. We'll go over the ANSI Z133 gear inspection requirements and why they are part of the safety standard. Equipment markings will be revealed and I will discuss decisions that must be made based on this information. For those interested in improving their gear inspection skills competency, various forms of readily available information will be shared as well as training opportunities. Equipment available to tree climbers today has potential to greatly increase job site safety; however, this equipment must be thoroughly understood and utilized within its limitations. Gear inspection knowledge is an essential part of this understanding and utilization.
